 - Beth and Ikea are still reviewing statistics for the Education/Income and Housing sections
 - Ikea is waiting to hear back from a few reports on the Housing section
- Land Capability- Ron Thompson, John Martinsen, Beth Dyke
 - o Kristy Hawthorne from Licking County Soil and Water (LCSW) presented at the meeting
 - o Suggestion to Wetlands Inventory Map and Groundwater Vulnerability Map
 - o Aquafer Vulnerability Map was presented at the meeting and can be received from LCSW
 - Soil Types Map will remain the same
 - o Prime Farmland Map will need updated
 - More detailed Soil Map can be provided if desired
 - Hydrologic Soil Map can be added to the plan if desired
 - Flood Plain Map will need updated
 - Generalized Land Use Map can be updated by Kyle at LCSW
 - o All of the maps that we need updated can be provided by LCSW
 - Ohio Geology Interactive Map is another good source for township maps
 - Other general notes...
 - "Water War" is going on in Licking County- most recent attempt to provide water to Western Licking County is in St. Albans township
 - Permitting processes required to "use" water from certain areas is governed by ODNR and EPA
 - Open spaces and floodplains are key for water regeneration and need to be protected
 - Over 1 acre of disturbance in flood plain requires strict review process
 - Packaged Sewer Plants are being rapidly processed to allow infrastructure in areas where there is no septic
 - Look into options to "opt out" of these plants in the township for Zoning Resolution update

 - Utica is getting ready to start comprehensive planning as well
 - Utica's sewer and water infrastructure have remained the same since last plan, with only changes being sustained maintenance.
 - Utica is looking to double sewage plant capacity from 450k/day to 900k per day
 - Do we know when this will take place?
 - As of 2022 county switched to GPS mapping and road mileages are slightly different
 - Rex is looking into this and can provide insight on surface upgrades
 - Mention aquafers in this section, but mainly reference in Land Capability
 - Can discuss Packaged Sewer Plants in this section if desired
