- The Fiscal Officer presented the Board with the estimated amounts and rates for tax collection from the Licking County Auditor for the Township for the year 2017.

Resolution 16-18 Mr. Smith moved to accept the amounts and rates as determined by the Licking County Budget Commission as follows: General Fund = \$70,956.00; Road & Bridge = \$85,135.00; 1.75 mil EMS levy = \$89,941.00; .8 mil EMS levy = \$47,883.00; 1.5 mil Fire levy = \$89,781.00; 3.0 mil Road levy = \$96,585.00.
