Lawton Coe - reported that he received the official notice for our records that the appeal for Dollar General has been dropped; 6399 Johnstown Road request appeal for the denied noise complaint of barking dogs; 11225 Wilson Road approved lot split; 8762 Weaver Road neighbor complained of shed/kennel added; and he received several calls about solar panels on resident's homes - the Township has no regulations for solar panels at this time.
2. Mr. Shaw - reported that the Township received American Relief money; and the Township received the opinion from the Licking County Prosecutor on the proper way to pay for the Township's share of the Ohio Fire Chiefs Feasibility Study for the Utica EMS and Utica Volunteer Fire Department.
