- 2. Branden McDaniel reported that he is working on the Township's F550 new lights and air tank; working on the snowplows; and drug Horns Hill Road.

Old Business:

- 1. Mr. Smith moved to table any action on the adoption of the west end of Ginger Hill Road for trash removal in memory of Rob Overly, until the Overly family agrees to pay for signs and signs a liability release. Seconded by Mr. Coad. Vote: Mr. Smith, yes; Mr. Coad, yes; Mr. Stevenson, yes. Motion carried.
- 2. Resolution 21-25 Mr Smith moved to contract with the Utica EMS to provide emergency medical services for the residents of Washington Township from 1/1/2022 to 12/31/2022. The payment for these services will be 90% of all money collected from the two levies for EMS services; 10% of the money collected will be held back for unexpected expenses for EMS services only. Seconded by Mr. Stevenson. Vote: Mr. Smith, yes; Mr. Stevenson, yes; Mr. Coad, yes. Motion carried.
- 3. Resolution 21-26 Mr. Smith moved to contract with the Utica Volunteer Fire Department for fire protection services for the residents of Washington Township from 1/1/2022 to 12/31/2022. The payment for these services will be 90% of all money collected from the levy for fire protection services; 10% of the money collected will be held back for unexpected expenses for fire protection services only. Seconded by Mr. Stevenson. Vote: Mr. Smith, yes; Mr. Stevenson, yes; Mr. Coad, yes. Motion carried.

- 4. Mr. Stevenson reported that the Township's grant writer completed and submitted in time the grant request through the ODOT program for guardrail on Stout Road.
