Employees and Appointees Report and Instruction:

1. Road Supt. Terry Banks reported: the Licking County Engineer is going to plate the bridge on Ginger Hill Road; he cleaned up the brush along Horns Hill Road; the tree on Ginger Hill Road at the Trout property is removed, and; we are missing a small battery charger. The Trustees will look at the stop sign at the end of Preston Road, and instructed Mr. Banks to put a little gravel on Horns Hill Road.

Reports:

- 1. Mr. Stevenson reported that he will apply for the ODOT sign project for upgrading signs on Preston, Cooksey and Peatmoss Roads.
- 2. The Board reported that they received an estimate to trim back the trees along Preston Road from Terry's Tree Service in the amount of \$350.00. They discussed the matter and will table the project for now.
- 3. The Board reported that the Utica EMS and the Utica Fire Department jointly purchased the school property on Spring Street in Utica for \$35,000.00 from the North Fork School Board.

Old Business:

- 1. The Board discussed the proposed joint fire district and the possibilities of the Township forming a fire department. The Board will discuss the matter at the next joint meeting with Morgan Township and the Village of Utica.
- 2. The Board discussed the developing holes on Cooksey and Peatmoss Roads. They will repair the holes weather permitting with cold mix.

New Business:

- 1. The contract for emergency medical services for the residents of Washington Township from the Utica EMS for the year 2015 was discussed.
- 2. Resolution 14-18 Mr. Londot moved to contract with the Utica EMS for emergency medical services for the year 2015. The amount paid for this contract will be the amounts generated by the .8 and 1.5 mil levies for EMS services; estimated amount to be \$139,452.00. Seconded by Mr. Coad. Vote: Mr. Londot, yes; Mr. Coad, yes; Mr. Stevenson, abstained. Motion carried.
