- 3. Mr. Coad reported that Clayton Shell from the Licking County Board of Elections is going to look at the Township office at 10905 Mt. Vernon Road tomorrow, February 26, to see if the residents could vote at that location.

Old Business:

1. The Board discussed the disbursements from the RUMA with the Devon Oil Company. The Trustees estimate that the Township will receive about \$18,230.00 for repairs to Torrens Road.

New Business:

1. The Trustees discussed the audit for the Township for the years 2011 and 2012. The Trustees decided to have a full audit performed; this will include a full financial audit. This will be required for any credit the Township could need in the future and will give a clear picture of the Township's financial situation.
