- 1. Mr. Stevenson reported that the Licking County Sheriff will check on large amounts of mud and manure on Weaver Rd. at the Torrens farm.
- 2. Mr. Shaw and Mr. Stevenson reported that they will attend a meeting on Feb. 16 with Don Robinson, Kendall Billman and Diane McQueen to look at the finances of the Utica EMS and Utica Fire Dept. to try and formulate a 5-year plan for the proposed fire district.
- 3. The Board reported that Gary Walters from the Ohio Plan will attend the next meeting to discuss the Township's liability insurance and employment policies.
- 4. Mr. Londot reported that Waste Management purchased Big "O" Refuse.
- 5. Mr. Stevenson reported that he received several bids to widen the rear door at the 10905 Mt. Vernon Road building.

## Old Business:

- 1. The Board discussed the bids for the widening of the rear door at the 10905 Mt. Vernon Road building. The Trustees discovered that the bids did not include the same materials. They will have the contractors re-bid the project using steel and wood to get a true comparison of prices.
- 2. Mr. Londot reported that he would like to see the Township start looking for a part-time road man to help Terry Banks with repairs to the Township's roads. Mr. Coad and Mr. Stevenson agreed. They will look to see if they can find someone to help Mr. Banks on a part-time basis.

## New Business:

- 1. Mr. Stevenson asked if the Board would be interested in purchasing a snow blower for the Township's tractor. The Board discussed the matter and Mr. Stevenson will get prices on used snow blowers.
- 2. The Board discussed the situation of Waste Management purchasing Big "O" Refuse,; they agreed the contract with Big "O" would not change.
- 3. Mr. Londot moved to continue the contract with Big "O", new owner Waste Management, for trash collection for the Township residents as long as the conditions of the contract are not change. Mr. Coad seconded. Vote: Mr. Londot, yes; Mr. Stevenson, yes; Mr. Coad, yes. Motion carried.
