- 1. Mr. Smith reported that he attended the Licking County Health Board meeting.
- 2. The Board reported that Joe Dager resigned from the Township's Zoning Commission. The Board thanked Mr. Dager for his many years of service to the residents of Washington Township.

- 1. The Board discussed the matter of replacing Mr. Dager on the Township's Zoning Commission.
- Resolution 18-15 Mr. Smith moved that Gary Smith be appointed to the Zoning Commission to replace Joe Dager, and further moved that Eric Adams is to be a regular member of the Township's Zoning Board of Appeals, with Jeff Esty being the alternate to the Board. - 3. The Board discussed the lawn care contract for the Township for 2018. 1st Response Lawncare LLC was the lowest bidder.
- Resolution 18-16 Mr. Smith moved to accept the contract from 1st Response Lawncare LLC for mow, trim and blow off all surfaces @ \$60.00 per mow. Seconded by Mr. Coad. Vote: Mr. Stevenson, yes; Mr. Smith, yes; Mr. Coad, yes. Motion carried.

1. The Board discussed the issue of legalizing the cultivation and sale of marijuana in the state of Ohio. They would like to prevent this activity in Washington Township.

Resolution 18-17 Mr. Smith moved that the Board, pursuant to R.C. 3796.29, is authorized to prohibit or limit, within the unincorporated territory of the Township, the number of cultivators, processors or retail dispensaries of medical marijuana, licensed under Ohio Revised Code Chapter 3796. Now therefore, be it resolved: that the Board of Township Trustees of Washington Township, pursuant to R.C. 3796.29, hereby prohibits, within the unincorporated territory of Washington Township, Licking County, Ohio, all cultivation, processors and retail dispensaries of medical marijuana, licensed under Ohio Revised Code Chapter 3796. Seconded by Mr. Coad. Vote: Mr. Stevenson, yes; Mr. Smith, yes; Mr. Coad, yes. Motion carried.
- 3. The Board discussed appointing Fiscal Officer Phil Shaw as keeper of the Township's records.
- 4. Resolution 18-18 Mr. Smith moved to appoint Phil Shaw as the keeper of Washington Township's records. Seconded by Mr. Stevenson. Vote: Mr. Stevenson, yes; Mr. Smith, yes; Mr. Coad, yes. Motion carried.
