Report and Instruction of Employees and Appointees:

1. Lonnie Richardson reported that the Township has very little salt left; the plow on the Louisville dump truck will need to be replaced sometime soon; the seat on the Cat backhoe needs repaired or replaced.

Reports:

1. Mr. Londot reported that he has not been able to get in touch with Tony Stocco to get instructions on how the Trustees should proceed with the Ogle and Kurber line fence situation.

Old Business:

1. The Board discussed the salt situation for the Township. They believe we have enough salt and #8 gravel to get through the rest of the winter. The Township received the application for the 2014-2015 salt contract with the State of Ohio. The Board will contract for 75 tons to be delivered in August and 145 tons for the winter season.

New Business:

1. The Board had nine Township residents in attendance. The residents all voiced their concerns about vehicles speeding on Cooksey and Peatmoss Roads. The residents reported that they have had many close calls trying to get in and out of their driveways, and that it has become dangerous

to take a walk along their roads. The residents reported that early in the morning, after school lets out and just before dark are the worst times for the speeding vehicles. Mr. Londot reported that he has already spoken to the Licking County Sheriff about the situation. The Sheriff will step up patrols in the area and set up the speed detector on Cooksey and Peatmoss Roads to hopefully slow down the traffic. The Trustees would like the residents to get the makes, models and maybe license plate numbers of the vehicles speeding if possible. The Board reported to the residents that this will be the first step in making the Township's roads safer.
