- The Board discussed the purchase of a dump truck to replace the 1998 Louisville truck. The Board looked at five different brands of truck/chassis and received 3 bids. The Board also discussed beds and equipment for this truck; they looked at several brands and received 3 bids as well.
- Resolution 22-13 Mr. Parsons moved that the Township purchase one 2023 International HV507 cab and chassis from Rush Truck Center/Lucas Trucks. The bid, reference HV507 4x2 (Proposal 24279-01), dated February 14, 2022, is in the amount of \$87,154.51. Seconded by Mr. Stevenson. Vote: Mr. Parsons, yes; Mr. Stevenson, yes. Motion carried.
- Resolution 22-14 Mr. Stevenson moved that the Township purchase as well, a Galion model #433U dump body, hoist, snowplow, lighting, salt spreader, spreader light option, vibrator kit, tarp system and automatic tire chains to be purchased from Dexter Company. The bid, "S.A. Truck Equipment Package", dated February 21, 2022, is in total amount of \$82,785.00. Seconded by Mr. Parsons. Vote: Mr. Stevenson, yes; Mr. Parsons, yes. Motion carried.
