- 1. Don Robinson reported that AEP will not talk with him about the Washington Township account. AEP is sending an authorization letter to the Township seeking permission to talk with Mr. Robinson on the Township's behalf. The Fiscal Officer will complete the authorization form and return to AEP.
- 2. Mr. Stevenson reported: reflectors are needed on the signs on Wilson and Weaver Roads; Mr. Banks has the rear end out of the Ferguson mowing tractor to repair the brakes; Mr. Stevenson is looking for help for the crack-seal project, and helpers must be 18 years old or older; one contractor is working on the bid for the rear door widening; the big truck's snow plow needs a new blade; Mr. Stevenson will encourage Mr.Banks to attend the Licking County Engineer's safety meeting on April 8; Mr. Stevenson will attend the tire recycling meeting; and Mr. Banks will start cold mix repairs when the weather permits.
