Employees and Appointees Report and Instruction:

- 1. Jim Dickson was present to inform the Trustees that he had a forester inspect the John Ogle property to get approval to maintain the property's CAUV status. Mr. Dickson reported that the forester said the property line between the Ogle and Kerber properties was not visible, and this could cause Mr. Ogle to lose his CAUV tax reduction. Mr. Dickson asked the Trustees to go and talk with Mr. & Mrs. Kerber to see if this situation could be resolved. Mr. Londot reported that until one of the parties involved in this dispute filed an official complaint with the Trustees concerning the partition fence, the Trustees had no authority in this matter per the Licking County Prosecutor's opinion.
- 2. Lonnie Richardson reported that he received an estimate of \$1,540.00 to repair the guardrail on Weaver Road; the F550 needs the front end looked at; the seat for the backhoe is not in yet; and he is out patching holes in the Township's roads.

Reports:

- 1. The Fiscal Officer reported that the Township's record retention plan was approved by the Ohio Historical Society.
- 2. The Board reported that Morgan Township would like to use the crack seal machine while the Township has it. The Board will look into the request.
- 3. Mr. Coad reported that the "Hidden Drive" sign on Wilson Road is too close to the road. The Board will have Lonnie Richardson move the sign away from the road.
- 4. Mr. Stevenson reported that the Village of Utica has a speed detector, and the Township can use it on the Township's roads or possibly purchase it from the Village. The Trustees will look into borrowing it at this time.

Old Business:

1. The Board discussed the Ogle and Kerber partition fence dispute. The Trustees agreed that they have no authority in this situation until one of the parties files an official complaint. They will wait to see if a complaint is filed with them.
