The Washington Township Board of Trustees met this date in regular session for the purpose of transacting business of the Township. Mr. Stevenson called the meeting to order at 5:00 p.m, the pledge was recited, and roll call was taken: Rex Stevenson, yes; Nelson Smith, yes; Sam Parsons, yes. Also present were Phil Shaw and Michele Lenger.

Public Participation Policy:

- 1. The Board discussed adopting a public participation policy which will limit the total public participation to 30 minutes unless an extension is voted on by the Board.
- Resolution 23-36 Mr. Smith moved to adopt the public participation policy to make sure the Board can conduct an orderly meeting, limiting participation of the public to 5 minutes per person, with total participation of 30 minutes per meeting unless an extension is voted on by the Board. (The full Public Participation Policy is attached to the minutes.) Seconded by Mr. Parsons. Vote: Mr. Smith, yes; Mr. Parsons, yes; Mr. Stevenson, yes. Motion carried.

Opening of Bids for Road Improvement Project 2023:

- 1. Mr. Shaw reported that he received one bid for the project from Small's Asphalt & Paving.
- 2. Bid as follows Performance bond = \$1,200.00; butt joints = \$1,200.00; 14" full depth repair = \$102.75; 24" full depth repair = \$192.60; tack coat = \$3.50 per gal.; 411 limestone = \$59.95 per ton; MC-3000 = \$4.40 per gal.; 441-1 asphalt concrete = \$89.85 per ton; 4" shallow underdrain = \$112.95 per lf; ditch on Ginger Hill = \$6.20 per lf; #1 & 2 limestone applied = \$54.30 per ton; maintaining traffic = \$1,300.00; and mobilization = \$10,700.00. Total for all areas requiring improvement = \$238,240.15.
- 3. The Board discussed the bids with Ms. Lenger.
- Resolution 23-37 Mr. Smith moved to accept the bid from Small's Asphalt & Paving, Inc. on a per-unit basis, with total cost of \$238,240.15 for all work required. Seconded by Mr. Parsons. Vote: Mr. Smith, yes; Mr. Parsons, yes; Mr. Stevenson, yes. Motion carried.

Mr. Smith moved to waive the reading of and approve the minutes for the meeting on 5/8/2023. Seconded by Mr. Stevenson. Vote: Mr. Smith, yes; Mr. Stevenson, yes; Mr. Parsons, yes. Motion carried.
