- 1. Lonnie Richardson reported that they have mowed all of the Township's roads one time.
- 2. The Board reported that they approved the fund balance report and that the Township's bank statement balanced for the month of May.

Old Business:

- 1. The Board discussed the audit report for the years 2011 and 2012. The report shows that all the Township's funds are accounted for during this time period.
- 2. The Board discussed the merger between the Utica EMS and the Utica Fire Department. They hope that all goes well with both groups becoming one organization.

New Business:

- 1. The Board received only one bid for the 2013 Road Repair Project. The bid was from Small's Asphalt Paving, Inc.
- 2. Mr. Torrens opened the bid. The bid is in a per unit basis as follows:
 - 4" underdrains (Richards Rd.) = \$3.93 per ft.
 - 12" N-12 conduit (Twp. complex) = 34.32 per ft.
 - Reclaim and grade (Twp. complex) = \$10,759.26 lump sum
 - Concrete extruded curb (Twp. complex) = \$10.34 per ft.
 - MC-3000 = \$3.47 per gal.
 - #89 Limestone = \$30.47 per ton
 - Tack coat furnished and applied = \$2.47 per gal.
 - 448-1 Concrete surface course = \$65.89 per ton
 - 448-2 Concrete surface course = \$63.15 per ton
 - 411 Limestone berm = \$27.32 per ton
 - Maintaining traffic = \$408.69 lump sum
 - Mobilization = \$2,439.12 lump sum
 - Performance bond = \$1,567.00 lump sum
