- 1. The Fiscal Officer reported that he received one bid for the 2016 Road Repair Project from Small's Asphalt & Paving, Inc. totaling \$204,049.25 for the entire project.
- 2. The Trustees inspected the bid, and Ms. Varrosso answered the Trustees' questions.
- 3. Resolution 16-16 Mr. Coad moved to accept the bid from Small's Asphalt & Paving, Inc. on a per-unit basis as follows: MC-3000 = \$2.30 per gal.; #8 limestone sealing = \$39.25 per ton; tack coat furnished and applied = \$2.50 per gal.; 448- asphalt concrete surface course = \$58.25 per ton; 448-1 asphalt concrete surface patching = \$95.00 per ton; excavation (ditch work) = \$20.00 per cy; 6" perforated (in ditch) = \$8.00 per ft.; 4" perforated (in ditch) = \$6.00 per ft.; #1&2 limestone = \$32.00 per ton; 617 gravel-compacted shoulder 2' wide = \$34.00 per ft.; maintaining traffic = \$7,480; mobilization = \$6,500; performance bond = \$1,515. Seconded by Mr. Smith. Vote: Mr. Stevenson, yes; Mr. Coad, yes; Mr. Smith, yes. Motion carried.

The Trustees also added that they would like the project completed before the start of school in August.
