#### Employees and Appointees Report and Instruction:

1. Road Superintendent Terry Banks reported: all the Township's roads are mowed; Horns Hill Road is graded and smooth; the Massey mowing tractor has a hydraulic leak; he ordered parts; he broke down and Judy Hall helped get a tire repaired. The Trustees instructed Mr. Banks to cut trees back on Horns Hill Road, cut tree back on Angeletti Lane, and put up signs on Weaver and Wilson Roads.

### Reports:

- 1. Mr. Londot reported that the Utica Fire Dept. cannot get any other grants until the 2012 grant is closed, and they have a lot of truck repairs to do.
- 2. Mr. Stevenson reported that the Utica EMS 24 hour paid coverage, Monday through Friday, will start on July 1<sup>st</sup>.
- 3. Mr. Shaw reported that the .8 mil EMS renewal levy will generate \$49,868.00, and the 1.5 mil Fire renewal levy will generate \$93,502.00 per the Licking County Auditor.
- 4. Mr. Stevenson reported that he had a complaint about the condition of Horns Hill Road.
- 5. Mr. Stevenson reported that the new door for the 10905 Mt. Vernon Rd. building will not be in until next Thursday.
- 6. Mr. Stevenson reported that the AC on the Case mowing tractor is not working.

- 1. The Board discussed placing the 1.5 mil fire levy and the .8 mil EMS levy on the November ballot as renewals
- 2. Resolution 15-13 Mr. Londot moved to place the .8 mil EMS levy on the November ballot as a renewal levy to begin in tax year 2016 to run for five years. Seconded by Mr. Coad. Vote: Mr. Londot, yes; Mr. Stevenson, abstained; Mr. Coad, yes. Motion carried.
- 3. Resolution 15-14 Mr. Stevenson moved to place the 1.5 mil fire levy on the November ballot as a renewal levy to begin in tax year 2016 to run for five years. Seconded by Mr. Londot. Vote: Mr. Londot, yes; Mr. Stevenson, yes; Mr. Coad, yes. Motion carried.
- 4. Mr. Coad reported that the crack seal material is in; now waiting on the weather to dry out.
