- 2. Mr. Stevenson reported that the new garage door opener for the rear door on the 10905 Mt. Vernon Rd. building is up and operating fine.
- 3. The Trustees would like to thank Zack Torrens and Daniel Green for helping with the removal of a fallen tree on Weaver Road.
- 4. Mr. Stevenson reported that Small's Asphalt Paving has completed three tile projects and is working on the fourth.

# Old Business:

- 1. The Board discussed the proposed budget for the Township for the year 2016.
- Resolution 15-17 Mr. Stevenson moved to accept the proposed budget for Washington Township for the year 2016 as follows: General Fund \$183,586.18, MVL Fund \$27,704.29, Gas Tax Fund \$124,991.66, Road & Bridge \$167,500.00, EMS Levy \$139,452.00, Fire Levy \$91,235.00. Total for all funds = \$734,469.13. Seconded by Mr. Coad. Vote: Mr. Londot, yes; Mr. Stevenson, yes; Mr. Coad, yes. Motion carried.

## New Business:

- 1. Dan Evers, Joe Dager, Luconda Dager and Rick Heath addressed the Board about a 100% tenyear real property tax abatement on the construction of a 21,000 square ft. freezer facility. They estimate that with this addition they will employ two more full-time employees and four more part-time employees.
- Resolution 15-16 After much discussion, Mr. Londot moved to recommend the execution of an
  agreement by the Board of Commissioners of Licking County to authorize the 100% ten-year real
  property tax abatement requested for the proposed Velvet Ice Cream, Inc. enterprise zone
  expansion project. Seconded by Mr. Coad. Vote: Mr. Londot, yes; Mr. Stevenson, yes; Mr. Coad,
  yes. Motion carried.
