Employee & Appointee Report & Instruction:

- 1. Lawton Coe reported that he received a noise complaint about the home on the corner of Mt. Vernon and Ginger Hill Roads; and the Dollar Store appeal is going forward he is waiting on transcripts of meetings for the Dollar Store.
- 2. Branden McDaniel reported that he mowed the Township's lots, he is mowing along the Township roads, and he sprayed for johnsongrass where needed.
- 3. Mr. Stevenson reported that the Utica EMS has a squad that either needs major repairs or replaced. The squad board is considering the matter.

Old Business:

- 1. The Board reported that there is no date set for the start of the 2021 Road Improvement Project.
- 2. Mr. Smith reported that the \$10 fee to have a spot in the community garden is to make sure the residents have a vested interest in Together we grow.
- 3. Mr.Stevenson reported that the township received 300 tons of salt @ \$60.47 per ton in the ODOT contract for 2021-2022 winter season.

New Business:

- 1. The Trustees discussed and will apply for American Rescue Act funding.
- 2. Mr. Smith reported that he received office furniture for the Township from the old Prosecutors' Office.
- 3. Resolution 21-23 Mr. Smith moved to approve the proposed budget for Washington Township for the year 2022: Carryover = \$375,143.75, receipts for all funds = \$787,190.00, total for all funds = \$1,162,333.75. 1. Mr. Summers commented about mutual aid for EMS and Fire Department and that it should be like the system the utilities use.
