Employees and Appointees Report and Instruction:

1. Terry Banks reported that: the brakes on the backhoe, Massey and the F-550 are all repaired; also repaired the skip plates on both mowers; graded Horns Hill Road and repaired the curve; drug Angeletti Lane and Lake Fork Road; removed the spreader from the Louisville dump truck; mowed Cooksey Road; and repaired the stop signs on Peatmoss and Hull Roads.

Reports:

- 1. Mr. Londot reported that a sheriff's deputy cannot be scheduled ahead of time for the view of the Kerber and Ogle partition fence. Mr. Londot will call two hours before the meeting time to get a deputy to accompany the Trustees to the meeting.
- 2. Mr. Londot reported that the tire collection held on July 26 was a great success. All three Trustees were able to attend. They collected 292 tires and gave Licking County Recycling \$298.00 from the collection day.
- 3. Mr. Stevenson reported that another tire collection day may be scheduled for next spring.
- 4. Mr. Coad reported that the Trustees had Extreme Asphalt repair a bad spot on Peatmoss Road as a test to see if their material will hold up.
- 5. Mr. Stevenson reported that the front end on the Township's Louisville dump truck seemed loose to him, and that the steering cylinder on the front of the road grader is leaking. The Board will look at both pieces of equipment.

Old Business:

- 1. The Board discussed the Road Repair Project for 2014. Mr. Coad reported that he hoped that Small's will get started in about two weeks.
- 2. The Board discussed the Ogle and Kerber partition fence viewing. They will all meet at the Township building at 5:30, then proceed to the site.

- Mr. Stevenson reported that Terry Banks was doing a very good job taking over the duties as Road Superintendent. Mr. Stevenson moved to raise Mr. Banks' hourly wage from \$18.25 to \$18.75 per hour. Seconded by Mr. Londot. Vote: Mr. Londot, yes; Mr. Coad, yes; Mr. Stevenson, yes. Motion carried.
- 2. The Fiscal Officer presented the Board with the budget for Washington Township for the year 2015.
