- 2. Mr. Coad reported that Greg Holton informed him of a limb that needed to be removed from Weaver Road. Branden McDaniel removed the limb.

Employee & Appointee Report & Instruction:

- 1. Road Superintendent Branden McDaniel reported: he replaced two hydraulic hoses on the arm mower; he replaced both batteries on the Louisville dump truck; he greased both mowers; and, he dragged Horns Hill Road and Angeletti Lane.
- 2. Jim Dickson was present to turn in zoning permits.

1. The Board reported that they looked at Weaver Road and had Hysong Tree Service removed the dangerous trees from along the roadway.

- 4. The Fiscal Officer presented the Board with the amounts and rates determined by the Licking County Budget Commission for the year 2020.
- Resolution 19-21 Mr. Smith moved to accept the amounts and rates determined by the Licking County Budget Commission for the year 2020 as follows: General Fund 1.1 mils = \$76,831.00, Road & Bridge Fund 2.2 mils = \$91,540.00, Road & Bridge Fund 3.0 mils = \$103,235.00, EMS Levy 1.75 mils = \$122,094.00, EMS Levy .80 mils = \$50,073.00, Fire Levy 1.50 mils = \$93,888.00. Total for all funds 10.35 mils = \$537,661.00. Seconded by Mr. Coad. Vote: Mr. Stevenson, yes; Mr. Smith, yes; Mr. Coad, yes. Motion carried.
