The Trustees instructed Mr. Banks that the Township's roads should be mowed next week, to get the salt bin ready for salt delivery, and to patch holes on Hull Road.

- 1. The Trustees reported that Small's Asphalt Paving is done with the 2015 Road Repair Project. They also reported that they are not happy with the job. They will discuss the matter with Bob Small.
- 2. Mr. Coad reported that representatives from the Licking County Engineer's office looked at Richards Road.
- 3. Mr. Stevenson reported that the Utica EMS increased their paid coverage to 8 am 8 pm seven days per week.

Old Business:

1. The Board discussed the summer salt fill program with ODOT. They are still waiting for this delivery.

New Business:

1. The Board discussed applying for funding from Ohio Public Works for the Richards Road widening project. They are not sure if there is enough time to complete the application for this year's grants.
