The Washington Township Board of Trustees met at 9:00 A. M. This day for the purpose of organizing for the year 1965.

Present Mr. Wince, Mr. Torrens; Mr. Mills and Mr. Reeder, Clerk.

Mr. Wince, the outgoing president, opened the meeting and the minutes of the December 29, 1964 meeting were read and approved.

Mr. Wince appointed Mr. Reeder, the clerk, to preside for the purpose of election of the officers for the year 1965.

The Clerk called for nominations for the office of Board President.

Mr. Mills nominated Mr. Torrens. Mr. Wince seconded the motion. There being no other nominations, Mr. Mills and Mr. Wince voted for Mr. Torrens. The chairman declared Mr. Torrens elected President for the year 1965.

Mr. Torrens nominated Mr. Mills for Vice President.

There being no other nominations, Mr. Torrens and Mr. Wince voted that Mr. Mills be elected Vice President. The chairman declared Mr. Mills elected Vice President for the year 1965.

The meeting was turned over to the new president.

Mr. Wince moved the adoption of the following resolution:

That the Board of Trustees of Washington Township meet in regular session on Monday, January 4, 1965 and the Board meet each and every two weeks thereafter for the year 1965. The time of the meeting to be at 7:30 P.M. in the township office. Mr. Mills seconded the motion.

Vote: Mr. Mills. yea Mr. Torrens yea Mr. Wince yea.
President declared the motion adopted.

Mr. Wince moved the meeting be adjourned. Mr. Mills seconded the motion. The president declared the meeting adjourned.
