The Washington Township Board of Trustees met in regular session this date for the purpose of transacting the business of the township.
Present were: Mr. Torrens; Mr. Wince; Mr. Londot; Mr. Kinney and Mr. Hull.

The minutes of the July 27th meeting were read and approved.

The clerk received on August 10th, 1970 a Notice of Annexation from John R. Loudon, Agent for Petitioners.

This Petition was for the annexation of 115.87 Acres more or less from Washington Township to the Village of Utica. The area, as described, is located east of the present Village limits and north of County Rd. #200.

A discussion was held on this annexation petition with the Board being generally opposed to the loss of any Township territory.
