The Washington Township Board of Trustees met in regular session this date for the purpose of transacting the business of the Township.

Present were: Mr. Torrens; Mr. Wince; Mr. Londot; Mr. Kinney & Mr. Hull.

The minutes of the Jan. 11th meeting were read and approved.

The Bond of Myers W. Hull, Road Supt. was received and approved by the Board.

Trustees Torrens and Wince had signed for the Township highway mileage as determined by the County Engineer and this report was forwarded to the State Highway Dept.

Township road record was received from the County Engineer, noted and filed.

The Examiners Report had been received from the Bureau of Inspection. This was thoroughly examined by the Board with the Clerk with all notations and comments of the examiner being noted.

Mr. John Weaver was re-appointed to the Zoning Commission with term to expire Nov. 17, 1975.

Mr. Frederick A. Davis was re-appointed to the Board of Zoning Appeals with term to expire Nov. 17, 1975.

The Annual Inventory of Township Machinery, Tools and Materials was prepared and the clerk was instructed to forward a copy to the County Engineer.

The report of condition of Bridges and Culverts was scheduled to be completed and made ready for approval at the next regular meeting.
