The Washington Township Board of Trustees met in regular session this date for the purpose of transacting the business of the township.

Present were: Mr. Torrens; Mr. Wince; Mr. Londot; Mr. Kinney and Mr. Hull.

The minutes of the February 22nd meeting were read and approved.

It was reported that the bridge on Twp. 251 had been repaired, and that the bridge on Twp 214 East of C 204 had not been repaired.

The road superintendant was instructed to remove an overhanging tree limb on Twp 76 near the Weaver residence.

The problem of Waste Disposal was briefly discussed. The Utica Village dump was due to be closed on or about March 18th and this would leave residents of the Township, who desired to haul their own, without a near disposal facility. It was not known at this time whether a facility would be provided.


Mr. Londot moved that the preceding bills be allowed as lawful obligations of Washington Township and that the Clerk be directed to issue warrants of the Township in payment of same.

The president declared the motion approved.


I certify that there are sufficient funds in the depository to pay the above bills and that checks have been issued in payment of same.




There being no further business before the Board, Mr. Wince moved that the meeting be adjourned.
