The Washington Township Board of Trustees met in regular session this date for the purpose of transacting the business of the Township.

Present were: Mr. Torrens; Mr. Wince; Mr. Londot; Mr. Kinney; Mr. Hull and Mr. John Ross.

The minutes of the Sept. 20th meeting were read and approved.

Mr. John Ross, Washington Township Zoning Inspector, appeared before the Board concerning his duties and responsibilities as Zoning Inspector. Answers to specific questions were gained by reference to the Township Zoning Resolution.

Mobile Homes and Trailers, as allowed and/or prohibited by the Zoning Resolution was a matter of extensive consideration. All questions related to this situation were not satisfactorily resolved. In order to have a better understanding of this part of the Zoning Resolution, Mr. Torrens, President of the Board, stated that he would set up a meeting with the Director of Regional Planning. This meeting would include the Board of Trustees and Clerk, the Zoning Inspector, and the Board of Zoning Appeals.
