The Washington Township Board of Trustees met in regular session this date for the purpose of transacting the business of the Township.

Present were: Mr. Torrens; Mr. Wince; Mr. Londot; Mr. Kinney.
Mr. Dave Norris; Mr. Richard Robinson and Mr. Gene Richards.

The minutes of the Dec. 14th meeting were read and approved.

The Clerk's Bond was approved by the Board.
The Trustees account books were verified and approved.

The organizational meeting was scheduled to be held Jan. 1, 1972 at 11:00 AM.

Mr. Norris asked whether or not anything had been done concerning the petition which he had presented at the previous meeting. He was again informed that the Board would handle it in the proper manner and according to law.

Mr. Robinson and Mr. Richards presented to the Board a Fire Protection Contract for a six month period beginning on Jan. 1, 1972 and expiring on June 30, 1972 for a total sum of seven hundred fifty dollars (\$750.00) same being payable in January of 1972.

Mr. Londot moved that this contract be accepted. Mr. Wince seconded.
