

The Washington Township Board of Trustees met in scheduled session this date for the purpose of organizing for the year 1972.

Present were: Mr. James W. Torrens; Mr. George F. Wince; Mr. Jack T. Londot and Mr. John E. Kinney.

Mr. Torrens, the outgoing president, convened the meeting.

The minutes of the Dec. 27th, 1971 meeting were read and approved.

Mr. John E. Kinney, re-elected Township Clerk presented his Certificate of Election, a receipt from the County Treasurer that his approved bond had been filed and, a statement certifying that his oath of office had been administered to him by Judge Robert J. Moore. These items were noted by the Trustees.

Mr. James W. Torrens, re-elected trustee, presented his Certificate of Election and his bond, properly approved; his oath of office had been administered by Judge Robert J. Moore.

The two above bonds are entered in the Township Bond Book.

Mr. Torrens relinquished the conduct of the meeting to the clerk for the purpose of electing a president for the year 1972.

The clerk called for nominations for the office of president.

Mr. Londot nominated Mr. Torrens. There being no other nominations, Mr. Londot moved that the nominations be closed. Seconded by Mr. Wince.

Roll call for President: Mr. Londot-Mr. Torrens; Mr. Wince-Mr. Torrens. The clerk declared Mr. Torrens the duly elected president and relinquished the meeting to him.

The president called for nominations for Vice President.

Mr. Wince nominated Mr. Londot.

There being no further nominations, Mr. Torrens moved that the nominations be closed; seconded by Mr. Wince.




Roll call: Mr. Torrens-Yes; Mr. Wince-Yes; Mr. Londot-Yes.


The president declared the resolution duly adopted.
