The Washington Township Board of Trustees met in regular session this date for the purpose of transacting the business of the Township.

Present were: Mr. Wince; Mr. Londot; Mr. Kinney and Mr. Hull.

The minutes of the March 6th meeting were read and approved.

On motion by Mr. Wince and second by Mr. Londot, Mr. Hull was authorized to take the Township truck to Mid City Tire Co., at Newark, Ohio for front end alignment and wheel balance, and if major repairs were needed, to check back with the Trustees before proceeding.

Mr. Londot suggested that the large culvert on Rd. 17 be checked for possible need of extension on one or both ends.
