A bulletin from The Public Employees Retirement System was received which specified retirement contribution rates for the calendar year beginning January 1, 1973 as follows:

Employee-member rate ----- 8.5% of compensation.

Employer rate----- 9.8% of covered payroll.

The above was noted and filed.

The Board discussed the work on Twp Rd 76 and it was of general opinion that progress was being made and should be complete within a few days, should the weather conditions be favorable.
