The Washington Township Board of Trustees met in regular session this date for the purpose of transacting the business of the township.

Present were: Mr. Torrens; Mr. Wince; Mr. Londot; Mr. Kinney and Mr. Hull.

The minutes of the April 17th meeting were read and approved.

Mr. Londot had contacted the Ecology Class of the local school concerning pick-up of trash along Township roads, and that the class was interested. Mr. Londot moved that the Ecology Class be hired to clean up trash along Washington Twp. roads and that they be paid a sum of \$50.00 (fifty dollars) for this service.

Mr. Wince seconded the motion.

Vote: Mr. Torrens-Yes; Mr. Wince-Yes; Mr. Londot-Yes.

The president declared the motion approved.

A culvert on Twp Rd. 205 south of CH 200 was reported to be faulty in drainage. The Board scheduled to investigate this situation and determine whether a new culvert was needed and if so, that it be installed.

The Board decided that foliage spray was needed near the bridge on Rd. 207.

The security lite located at the junction of CH 200 and Twp. 206 was reported to be out. The clerk was instructed to call the Elec. Co. and report same.
