

The Washington Township Board of Trustees met in scheduled session this date for the purpose of organizing for the year 1973.

Present were: Mr. James W. Torrens; Mr. George F. Wince; Mr. Jack T. Londot and Mr. John E. Kinney.

Mr. Torrens, the outgoing president opened the meeting.

The minutes of the Dec. 28th meeting were read and approved.

Mr. Torrens relinquished the conduct of the meeting to the Clerk for the purpose of electing a president for the year 1973.

The Clerk called for nominations for the office of president.

Mr. Londot nominated Mr. Torrens. There being no other nominations, Mr. Wince moved that the nominations be closed and Mr. Londot seconded the motion. Vote: Mr. Torrens-Yes; Mr. Wince-Yes; Mr. Londot-Yes.

Roll call for president: Mr. Londot-Mr. Torrens; Mr. Wince-Mr. Torrens. The clerk declared Mr. Torrens the duly elected president and turned the conduct of the meeting back to him.

The president called for nominations for vice president;.

Mr. Wince nominated Mr. Londot. There being no further nominations, Mr. Wince moved that the nominations be closed. Mr. Torrens seconded the motion. Vote: Mr. Torrens-Yes; Mr. Wince-Yes; Mr. Londot-Yes.

Roll call for vice president: Mr. Torrens-Mr. Londot; Mr. Wince- Mr. Londot. The president declared ~~Mr.~~ Mr. Londot the duly elected vice president.






Mr. Londot seconded the motion.
