The Washington Township Board of Trustees met in regular session this date for the purpose of transacting the business of the Township.

The minutes of the Jan. 15th meeting were read and approved.

The Township Trustees Annual Report of Highway Bridges and Culverts was reviewed, updated and approved by the Washington Township Board.

The annual Appropriations for 1973 had been completed at a previous meeting and the clerk had presented a copy to the County Auditor and had received from the County Auditor his "Certificate that the Total Appropriations from each Fund do not exceed the last Amended Official Estimate of Resources."
