The Washington Township Board of Trustees met in regular session this date for the purpose of transacting the business of the Township.

Present were: James W. Torrens; George F. Wince; Jack T. Londot; John E. Kinney and Myers W. Hull.

The minutes of the February 5th meeting were read and approved.

This meeting had been postponed from February 19th.

The present Township office space being poorly located, inadequate as to size and not affording a place for voting, Mr. Wince moved that:

The Township Trustees enter into a contract with W.J. Wilson Jr. for rental of office space at 16 South Main Street for a period of three years at a rental cost of forty dollars (\$40.00) per month. Landlord agrees to pay for water and sewer with any other expenses including heating and lighting equipment to be provided by the Trustees.

Mr. Londot seconded the motion.

Roll call vote: Mr. Torrens-Yes; Mr. Wince-Yes; Mr. Londot-Yes. The president declared the motion approved.

Roll call vote: Mr. Torrens-Yes; Mr. Wince-Yes; Mr. Londot-Yes. The president declared the motion approved.

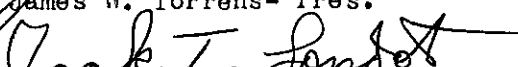
I certify that there are sufficient funds in the depository or in process of collection to pay the above bills and that checks have been issued in payment of same.

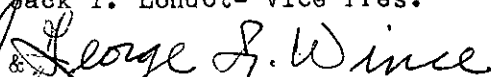

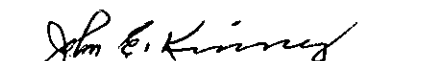
There being no other business before the Board, Mr. Wince moved that the meeting be adjourned. Mr. Londot seconded the motion.
