The Washington Township Board of Trustees met in regular session this date for the purpose of transacting the business of the Township.

Present were: Trustees-James W. Torrens, George F. Wince, Jack T. Londot
Clerk-John E. Kinney; Road Supt-Myers W. Hull and
Harper Donald, Township resident farmer.

The minutes of meetings March 3rd and 17th were read and approved.

State examiner, Albert W. Knicely, met with township officials on March 20th and reviewed the examination of the Township records. Except for a few minor items, the records were considered to be very satisfactory.

Mr. Donald stated to the Board that he wanted to build a fence along the south side of Twp. Rd. 75A (Coad cemetery dead end road) and asked for assistance in locating this fence. The Board scheduled to meet with Mr. Donald on April 5th to determine fence line.

By mutual agreement, Mr. Londot was appointed to contact the School Ecology Class and make arrangements for the class to pick up trash along Township roads at a cost of \$50.00.

The driveway to the Township lot was considered to be too narrow for present day use. In order to widen this drive, the culvert would have to be extended and additional fill added. The Board scheduled to contact Mrs. Mary Florence Cree, the adjacent property owner, on the matter.
