The Washington Township Board of Trustees met in regular session this date for the purpose of transacting the business of the Township.

Present-Trustees: James W. Torrens, George F. Wince, Jack T. Londot.

Clerk: John E. Kinney and Road Supt: Myers W. Hull.

The minutes of the special meeting of June 27th were read & Approved.

The Board had been working for quite some time toward the purchase of a new tractor with loader and mower. Detailed specifications of the equipment to be purchased were completed and other information to be contained in the advertising being specified,
