
Mr. Londot moved that the preceding bills be allowed as lawful obligations of Washington Township and that the clerk be directed to issue warrants of the Township in payment of same.

Mr. Torrens-Yea; Mr. Wince-Yea; Mr. Londot-Yea.


The president declared the motion approved.


I certify that there are sufficient funds in the depository or in process of collection to pay the above bills and that checks have been issued in payment of same.




