The Washington Township Board of Trustees in regular session this date for the purpose of transacting the business of the Township.

The minutes of the June 20th meeting were read and approved.

The spraying of weeds and brush along Township roads was discussed by the Board and Thursday evening July 7th was scheduled for determining the portions to be sprayed.

The Washington Township budget for the year ending December 31, 1978 was prepared in tentative form at this meeting. Hearing on the budget had been scheduled and advertised for July 18, 1977 in the Township office.

Mr. Wince moved that the budget be accepted and approved subject to change at the hearing.
