The Washington Board of Trustees met in regular session this date for the purpose of transacting business of the Township.

Present for the meeting were Trustees: James W. Torrens, Jack T. Londot and George F. Wince, Clerk Neil D. Reeder and Road Supt. Myers W. Hull.

The minutes of the meeting of January 1, 1981 were read and approved.

Resolution hiring Road Superintendant and establishing rate of pay for Employees:

Mr. Londot moved that Myers W. Hull be hired as Road Supt. for the year 1981 and that his rate of pay be Seven Dollars per hour and that he be paid at the rate of time and one half for overtime above forty hours in any calendar week and that he be allowed vacation pay of (\$560.00) Five Hundred and Sixty Dollars which is 80 hours at regular rate of pay and that other employees be paid at the rate of (\$5.50) per hour. The above rate to begin January 1, 1981. Mr. Wince seconded the motion.

Resolution allowing expenses and authority and retaining Zoning Inspector:

Item 1.

That the necessary expenses incurred by Township Officials while in attendance at State Association meetings and County Association meeting and in the performance of Official business be allowed at cost and that mileage be allowed at twenty one cents per mile, garage at cost and that telephone expense be allowed at cost.

Item 2:

That the Clerk be allowed to purchase postage and other ordinary and necessary office supplies as needed and that he be reimbursed for purchases for which payment on presentation of receipt and paid bills.

Item 3:

That each Trustee be given authority to take care of any emergency as deemed necessary by each Trustee and that each Trustee be allowed to instruct the Road Superintendant in handling emergencies.


Item 4:


That the Zoning Inspector James L. Dickson, be retained at a pay rate of One Dollar (\$1.00) per each calendar day and that he be allowed mailing expenses, telephone expenses and that he be also allowed mileage at 21 cents per mile for travel while in the performance of his duties.
