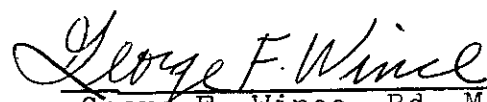
The first meeting for the year 1982 will be held January 1, 1982 for the purpose of organizing the Board.

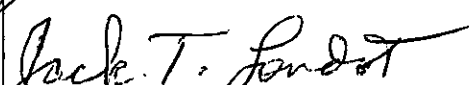
There being no further business on motion of Mr. Wince and seconded of Mr. Londot the meeting adjourned.
