The Board of Trustees of Washington Township met in regular session this date for the purpose of transacting business of the Township.

The minutes fo the meeting of July 25, 1983 were read and approved.

Mr. Londot made the following motion and moved for its addption:

Whereas, The Board of Trustees of Washington Township had excepted the bid of \$26,990.00 on the purchase of a Tractor and Mower, and Whereas, there is not sufficent funds in the depository to make complete payment of the amount due on said purchase and also meet current expenses of operations,

A note to Banchoio National \$20,000.00 due one
