
The minutes of the meeting of July 21, 1986 were read and approved.



Vote: Wince, Hull and Torrens, Yea.


I certify that there are sufficient funds in the depository or in the process of collection to pay the above bills and checks of the Township have been issued in payment of the same.

The board discussed zoning and the zoning commission requested to meet with the board at the Sept. 8, 1986 meeting. After input from several residents and discussion among the board Mr. Hull made a motion to close a section of Wilson Rd. (208) from a point approximately .8 miles south of Blacksnake Rd. and south of the last utility pole approximately 75 feet and ending at a point approximately 1.3 miles south of Blacksnake Rd. The motion was seconded by Mr. Wince. Vote: Wince, Hull, Torrens, Yea. Mr. Torrens was to check with commissioners about a petition for this goal.

Meeting adjourned on motion of Mr. Hull and seconded by Mr. Wince.
