
The minutes of the meeting held November 27, 1989 were read and approved.


A motion was made by Mr. Hull that the Township pay for incoming Trustee Jack Londot's cancer insurance policy. Mr. Wince seconded the motion, vote unanimous.

Mr. Torrens reported that Tim Lollo from the Engineer's office stated that the bridge on ~~East Hill~~ ^{Brown Hill} Rd. was near the top of the list in the county for repair. All the Trustees felt relieved that the bridge would soon be repaired.


Mr. Torrens also brought information regarding the new CDL license requirements and an explanation of the process for obtaining it. If a chauffer's license is in possession before Jan, 1, 1990 then the applicant must merely take the written test. However if no chauffer's license is obtained prior to that date then both a skill and written test must be taken.

The St. John situation was discussed, with the Trustees feeling that they should back up the Board of Zoning Appeals. Myers will check with Randy Wheeler and request a written decision from the Board as to their exact findings. It was also felt Randy should send a copy to Mr. St. John. Mr. Torrens will check with Debbie Kinney-Nethers on the next step of the Trustees should that next step be needed.

Mr. Wince moved the meeting be adjourned, seconded by Mr. Hull, Vote unanimous.
