1. Jim Dickson, zoning inspector, was present and submitted zoning applications and fees. He also gave the trustees his report on zoning in the Township, stating that everything concerning zoning in the Township is in fine shape.
2. Resolution 92-03 - Mr. Londot moved that Washington Township buy a desktop copier for office use. Seconded by Mr. Hull, vote unanimous.
3. Resolution 92-04 - Mr. Hull moved that Washington Township adopt Ohio Revised Code Section 3734.55. The Final Draft Solid Waste Management Plan of Coshocton, Fairfield, Licking and Perry solid waste district. Seconded by Mr. Torrens, vote unanimous.
4. Resolution 92-05 - Mr. Torrens moved that new rear tires for the backhoe be purchased from Bob Cline at a cost of \$264.00 per tire ~~mounted~~. Seconded by Mr. Londot, vote unanimous.
5. Mr. Londot and the other trustees discussed if he should be paying into Medicare. They decided that Mr. Londot should be paying into this program and that he would pay 1.45% of his wages back to January of 1990.






