3. The Trustees discussed the dust problem in the Township. Jerry Hull is going to call Dan Frazee to get brine applied to the roads where needed.
4. Jerry Hull priced rear tires for the Township's Ford tractor. The Trustees approved the purchase of these tires from Kidwell Tire at a cost of \$286.00 plus \$25.00 installation each.
5. Mr. Torrens reported that Phil Roberts, who lives on Cooksey Road, questioned why there was no dust pad at his drive. Mr. Torrens inspected the road and could see no reason for a dust pad at that location. No action taken.
6. The Trustees reported that the dust pad projects on Cooksey, Hull and Peatmoss Roads were complete and looked good.

Mr. Londot moved to adjourn, seconded by Mr. Torrens, vote unanimous.
