1. The Trustees discussed the upcoming zoning meeting sponsored by the Licking Co. Prosecutor's office. They hope that all zoning board members attended.


2. Mr. Torrens reported that the Township's road levy expires in 2002, not in 2001.


3. The Board discussed if there was a need to revise the Township's zoning ordinances.

New Business:


No new business.
